



Safeguarding Training – Accredited training giving your staff a qualification

What does the training cover?

The safeguarding training is an accredited course licensed by Nuco Training (the accreditation centre) and so it has to follow a standard course structure. This covers both children and adults safeguarding and looks at policies and procedures, different types of safeguarding and the indicators, reporting and recording, how to address safeguarding, making judgements and a whole host of other areas.

What is the difference between Level 1 and Level 3

Level 1 is a 5 hour course (including breaks) and this is suitable for frontline workers. It gives an overview of the basics of safeguarding, including the all important reporting and recording.

Level 3 is a more in-depth one day course, and is suitable for managers or Designated Safeguarding Leads. It looks in more detail at responsibilities in safeguarding, about the requirement to work within the local safeguarding partnership and thinks about the role of managers of safeguarding within the organisation as well as within your client group.

Both courses can be delivered either face to face or live online.

What are the learning objectives of the courses?

For Level 1:

1. Be aware of safeguarding legislation and guidance
2. Be aware of key safeguarding roles
3. Be aware of different types of abuse
4. Be aware of signs and indicators of abuse and neglect
5. Know what action to take if a safeguarding concern arises

For Level 3:

1. Understand how to safeguard and protect children, young people or vulnerable adults in the workplace
2. Know how to respond to evidence or concerns that a child, young person or vulnerable adult has been abused

How is the qualification assessed?

Each qualification has a knowledge check or assessment at the end of the course. For online courses, this will be professional discussion booked after the course. This covers all of the detail covered in the course, and assures yourself, and the trainer that the person is competent in safeguarding at the required level.

Is it a standard course or can it be tailored?

To make sure you get the most out of the course, the trainer will tailor it to your client group. This will include more relevant videos, case studies and scenarios and facilitating conversation about the most relevant areas of safeguarding for your client group.

What is the cost?

Level 1 is £550 which includes pre administration, delivery of course and post qualification administration. There is an additional £12.50 per learner for the required book and qualification certificate (This is electronic – if you require a printed certificate please request, the price is slightly higher). This works out at £67.50 per person if you have 10 learners on the course and £42.18 if you're able to fill the full 16 places.

Level 3 is £775 for the full day course which includes pre administration, delivery of course and post qualification administration plus £12.50 per learner for the required book and qualification certificate (This is electronic – if you require a printed certificate please request, the price is slightly higher). This works out at £90 per person if you have 10 learners on the course or £75 per person if you're able to fill the full 12 places.

Please note smaller charities and community groups can access a discount on this course so please contact me to discuss your organisation further if this applies to you.
